Dear Ms. Hamilton,


Your brother and co-beneficiary of the above-referenced Trust, Alan Hamilton, has contacted me regarding the frustration he is experiencing as the result of being denied access to funds he needs and had been using to do the maintenance, repair, and renovation of Trust properties. I am referring specifically to the Yokum National Bank checking account which your father gave signatory rights to Alan just as your mother gave you the rights to the Guaranty Federal Bank account. Apparently you and/or your mother depleted the Yokum account for ongoing expenses leaving Alan unable to continue his work.

There are remedies to this problem ranging from the simple, civil, and rational to the complex, litigious, and expensive. Alan seeks an uncomplicated, direct, and equitable resolution and he is open to your suggestions. One immediate solution is the simple division of one or more of the three annuities in Alfred's name. Alan will of course keep accurate records of Trust expenditures from his share of any annuity distribution to facilitate proper bookkeeping.

Simple cooperation will be cost-saving and productive for Maurine, Alan, and yourself. In this connection providing Alan the accounting of Trust assets to which he is entitled could help bring the family together, save an enormous amount of trouble, and secure Alan's enthusiastic support of projects you and Maurine want completed. In other words, Alan will gladly resume the work he has been doing for the family for the past twenty years. He simply needs the means with which to do so.

Please contact me or Alan and we will do our best to work cooperatively with you.
